Fiscal Year 2020 was a challenge for many in our community, and Saint Julia Parish was no exception. Our budget and expenditures for our year starting July 1, 2019 and ending June 30, 2020 reflect a mixture of the positive momentum that we had generated through our FY2019 mission focus, and the reality of COVID-19 that upended life as we knew it in mid-March.


The figures below tell that story, namely that FY2020 was shaping up to be one of our best—our grand annual collection (most of which was collected by December 31, 2019) recovered from last year's low, and our offertory was on pace to give the parish net positive income for the year. Unfortunately, COVID-19 has affected our parish's finances dramatically, particularly for our offertory collection, as reflected by the change in average weekly offertory since March.

While this Annual Report covers the reporting period from July 2019 through June 2020, it is important to note that the negative trends in offertory continue into FY 2021 beginning July 2020.

Thank you for your prayerful consideration of this year's Annual Report.

BUDGET TO ACTUAL

We have been careful stewards of the parish's resources and have not had to draw down our fund balance. However, due to the cash shortfall in the budget, our Total Net Assets decreased by \$22,596. The Accounts Payable balance was less than last year, at just over \$14,000. The parish received a Payroll Protection Program (PPP) loan in the amount of \$86,000. At present, that loan sits on our books as a liability. However, pursuant to the terms of this loan program, it is our hope that all or most of this loan will be forgiven and therefore show as revenue on the FY21 Financial Statement.

Of particular note, our Total Revenue came in over 11% under budget. As mentioned on the previous page, however, since March, revenue has been down over 20% across the board. Our Grand Annual, collected mostly in Q4 of 2019, increased over last year but still fell short of our goal. Religious Education was hardest hit by COVID-19 and revenue was more than cut in half. Total Expenses remained steady through February but were dramatically reduced across the board beginning in March, resulting in a decrease of more than 8% in budgeted expenses, with largest reduction in expense resulting from layoffs the when necessary. Facilities furlouahs Expenses and remained stable. We now have purchased high-end purifiers for the church to keep parishioners safe through COVID.

SUMMARY

Each year, we strive to put together a budget that reflects the mission of Saint Julia's Parish while at the same time being faithful stewards of the resources entrusted to us by our parishioners. FY2020 threw our budget a curveball, but our team adjusted! Please help us to achieve our two-fold goal of caring for our beautiful churches and parish center while at the same time continuing to focus on our missionary work in the community and beyond!
